Conference Details: This year's conference will take place in End, Oklahoma at the Stride Bank Center at 301 S. Independence Avenue.

Conference Theme: This year's theme is **VOICES AND VISION**. The 2026 AIA Architecture Conference invites proposals that explore how architecture is shaped by the voices we listen to and the vision we choose to lead with. *Voices & Vision* celebrates work that prioritizes human experience, equity, community, and collaboration; recognizing that the most impactful design begins with understanding people.

We are seeking speakers who can share thoughtful insights, compelling stories, and practical lessons that demonstrate how people-centered design influences the built environment. We welcome diverse voices, backgrounds, and firm sizes, and encourage proposals that spark conversation and broaden how we define architectural impact.

Compensation: Complimentary registration will be offered to all speakers. Keynote speakers from outside of Oklahoma will also be offered a stipend to assist with expenses, including airfare, hotel, meals, etc.

F. LEARNING OBJECTIVES

HSW definition: Licensed architects and affiliated design professionals have, in their professional practice, a positive duty to protect the public's health, safety, and welfare. Learning programs must address knowledge intended to protect the health, safety, and welfare of the occupants of the built environment, as defined below:

- **Health** Those aspects of professional practice that improve the physical, emotional, and social well-being of occupants, users, and any others affected by buildings and sites.
- **Safety** Those aspects of professional practice that protect occupants, users, and any others affected by buildings or sites from harm.
- **Welfare** Those aspects of professional practice that enable equitable access, elevate the human experience, encourage social interaction, and benefit the environment
